If a family has more than one child registered in the Elementary program in the same year, there will be a reduction of 10% in the oldest child's tuition.

## **Payment Plans for Tuition**

**Allegro requires all application, activity, supply fees, and tuition be paid upon receipt of invoice(s).** \*

Tuition must be prearranged using one of Allegro's three payment plan options.

1. Full payment: due May 1<sup>st</sup>, 2025 *(or upon acceptance if later)*.
2. Biannual payments: due May 1<sup>st</sup>, 2025 *(or upon acceptance if later)*, and December 1<sup>st</sup>, 2025.
3. Installments: 10% of tuition total due May 1<sup>st</sup>, 2025, and re-occurring August 1<sup>st</sup>, 2025, through April 1<sup>st</sup>, 2026.

When a student is accepted for less than a full year, all fees plus a minimum 20% of a full year's tuition total is required upon notice of acceptance and prior to start date. The balance of tuition is due in equal installments beginning on the 1<sup>st</sup> day of the month (in relation to start date) through April 1<sup>st</sup>, 2025, or can be paid in full upon acceptance.

The installment payment plan is not to be viewed as monthly payments that correlate with months of school to be attended and are simply a means to make attending Allegro more feasible for families.

**You are not considered fully registered until the above criteria is met.**

## **Payment Method**

All payments are made using an online payment system called TUIO. A TUIO account is created when you make your initial application to the school. Once the application is reviewed, you will be contacted by TUIO with an instructional e-mail to assist in finalizing your application fee payment and account information.

**Without payment, your application to Allegro Montessori will not be considered.** Upon acceptance into a program, subsequent invoices will be created & families must access their Tuio account to setup a payment method. Families have the option to pay with debit or credit.

Please note that payments completed with credit card is subject to \$0.35+3.5% processing fees. Payments completed with a connected bank account by direct debit are **not subjected to processing fees.**

## **Outstanding Accounts**

All fees and tuition shall be paid as outlined above. A child is not considered registered until the fees outlined above are paid. **Allegro Montessori reserves the right to request the withdrawal of a child if tuition payment plan selected is not upheld.**

## **Withdrawals & Tuition Balances:**

Tuition and fees will not be adjusted for illness, voluntary absences, school vacation, professional development days, or other unforeseen circumstances.

To withdraw, **written notice must be provided at the latest on the first day of the month before withdrawal.** Any notice of withdrawal received past the deadline will have an official withdrawal date of the following month. Such written notice must be addressed to the school office and to the attention of the Head of School of Allegro Montessori School Inc.

The date of the written notice of withdrawal will determine the percentage of the annual tuition that is due and to be retained. The following schedule outlines those amounts to be retained:

## Monthly Rates

Monthly Rates are available for families based on a yearly commitment. Monthly Rates include unlimited usage based on your selection and are not adjusted for days not attended. Invoices for Monthly Rates are issued at the beginning of each month beginning September 1<sup>st</sup>, 2025, and re-occurring through June 1<sup>st</sup>, 2025. In the event you wish to cancel your Monthly Rate, notice must be received 15 days prior to your next payment withdrawal date. Once canceled, Monthly Rates cannot be reinstated for the remainder of the school year.

## Casual Rates

Casual Rates are available for families throughout the year. Same day registration for Allegro-In-Between and Extended Care P.M. can be arranged by calling Allegro's Office Manager. Same day registration for Extended Care A.M. and Extended Care P.M. can alternatively be arranged using Brightwheel's messaging system. Invoices for all Casual Rates will be issued after the last day of each month. Casual Rates are based on recorded usage from the 1<sup>st</sup> to 31<sup>st</sup> of the previous month.

## Additional Information

If you are paying Monthly Rates and use an additional Casual Rate, you will receive two separate invoices. Your initial rate selection is based on information you provided in your on-line application. To update your information please contact Allegro's Office Manager.

Any student not picked up before 3:45 p.m. will be sent to Extended Care and contacts will be notified immediately for pick up. Casual Rates will be charged as outlined above.

## Outstanding Accounts

Your child will not be permitted to attend Extended Care programs if your Monthly or Casual invoices become two months in arrears.
